# PropsMadness \$10,000 Competition - Terms & Conditions

Last updated: October 20, 2025

These Terms & Conditions ("Terms") govern participation in the **PropsMadness \$10,000 Competition**("Competition") organized by **DataLens d.o.o.**, a company registered in Croatia under VAT ID **HR38508594362**, doing business as **PropsMadness** ("Organizer", "we", "our", "us").

By entering the Competition, each participant ("Participant", "you") agrees to be bound by these Terms.

#### 1. Overview

The Competition rewards participants who refer the highest number of new, first-time PropsMadness subscribers by **December 31, 2025, at 23:59:59 CET**. Participation is free and based purely on skill and performance. **This is not a game of chance.** 

#### 2. Duration

• Start date: October 21, 2025

End date: December 31, 2025, 23:59:59 CET

• Winners announced: January 1, 2026

# 3. Eligibility

- Open to individuals aged 18 years or older as of the start date.
- This Competition is void where prohibited by law. Participants must be residents of countries where Deel, Tolt, or PayPal can legally process payments. The Organizer reserves the right to request proof of residency and to disqualify participants from jurisdictions where payment processing is not available or where the Competition violates local regulations.

# 4. How to Participate

- 1. Each participant receives a unique **referral link or code** generated through the PropsMadness referral system (via Stripe and Tolt).
- 2. Share your referral link or code publicly or privately to encourage new users to join PropsMadness.
- 3. A valid referral is counted only when:
  - They purchase their first PropsMadness subscription through the participant's unique referral link or code before the end of the Competition period
  - The purchase is successfully processed (not refunded or charged back)
- 4. Fraudulent, duplicate, or self-referrals are not permitted and will be disqualified.
- 5. Any attempt to manipulate or circumvent the referral tracking system will result in a disqualification.

The Organizer's internal tracking data will be considered final and binding.

#### 5. Prizes

#### **Main Prizes:**

- 1st Place USD 5,000
- 2nd Place USD 2,500
- 3rd Place USD 1,500

#### **Bonus Prize:**

An additional USD 1,000 will be awarded to one participant who has actively and creatively promoted PropsMadness during the Competition, as determined by the Organizer's internal review panel. This selection is **based on merit and engagement**, not random draw.

## 6. Winner Selection and Notification

- Winners will be determined according to the number of valid first-time subscriber referrals recorded by the end of the Competition period.
- In the event of a tie (two or more participants with the same number of valid referrals), the participant whose final qualifying referral was recorded first (by timestamp in the PropsMadness system) will be ranked higher.
- The Organizer will contact winners by email or direct message within **five (5) business days** of announcement.
- Winners must respond within **seven (7) days** of notification to confirm payment details.
- Failure to respond within that timeframe may result in forfeiture of the prize and selection of the next eligible participant.

# 7. Prize Payment

- All prizes are paid in **USD** via **Deel, Tolt, or PayPal**, according to the winner's preference where possible.
- Payments will be processed within **14 days** after:
  - Winner has confirmed their payment details, AND
  - Identity/residency verification is completed (if required by the Organizer)
- All prizes are paid as gross amounts. Winners are solely responsible for:
  - Any income tax, VAT, or other taxes applicable in their jurisdiction
  - Reporting prize winnings to relevant tax authorities as required by local law
  - Any fees charged by payment processors (Deel, Tolt, or PayPal)
- The Organizer may request proof of identity or residency prior to payout.

# 8. Disqualification and Fraud

The Organizer reserves the right to disqualify any participant who:

- uses fake, duplicate, or automated signups;
- manipulates or circumvents the referral tracking system;
- violates these Terms or acts dishonestly.

Decisions of the Organizer are final and not subject to appeal.

# 9. Data Privacy

- The Organizer collects and processes only the data necessary to run the Competition (e.g., referral codes, contact details, and subscription confirmations).
- All personal data is processed securely in accordance with Regulation (EU) 2016/679 (GDPR).
- Participants can contact hello@propsmadness.com to request data access or deletion once the Competition concludes.

## 10. Liability

- The Organizer is not responsible for technical issues, system errors, or network problems that may affect participation or referral tracking.
- The Organizer reserves the right to amend, suspend, or terminate the Competition if unforeseen circumstances arise that prevent its fair completion, including but not limited to technical failures, payment processor outages, regulatory changes, or force majeure events. Material changes to these Terms will be communicated to all registered participants via email or direct message at least 7 days before taking effect. Continued participation after notification constitutes acceptance of amended

Terms.

## 11. Promotional Conduct

Participants may not:

- Make false, misleading, or exaggerated claims about PropsMadness
- Use spam, unsolicited messages, or automated bots to distribute referral links
- Impersonate PropsMadness, its employees, or representatives
- Violate any platform's terms of service while promoting their referral link

The Organizer reserves the right to disqualify participants who engage in unethical or harmful promotional practices.

# 12. Governing Law and Jurisdiction

These Terms are governed by the laws of the **Republic of Croatia**. Any disputes arising from or related to this Competition shall fall under the exclusive jurisdiction of the competent court in **Zagreb**, **Croatia**.
